(SLB) is a charitable organization established in 2020 to empower college excellence through comprehensive basic needs support. Using innovative resource recovery initiatives, SLB addresses food insecurity and hunger by providing nutritious meals and essential supplies to economically disadvantaged college students across Los Angeles County, enabling them to focus on their education and reach their full academic potential.

Student LunchBox, Inc. (SLB) advanced its mission to promote academic success by providing consistent food and basic needs support to college students across Los Angeles County. In 2025, SLB recorded 153,395 student visits, serving 53,671 unduplicated students across 17 partner campuses while distributing 992,180 pounds of food, equivalent to 826,817 meals, and \$314,974 worth of clothing, toiletries, household goods, and other necessities. This work provided meaningful financial relief, supported students' mental and physical well-being, reduced stigma around seeking assistance, and strengthened their ability to remain focused and persist academically. SLB's food recovery efforts also produced measurable environmental benefits, conserving an estimated 66.41 million gallons of water and preventing approximately 490.48 metric tons of CO2e emissions. The organization also received 11,341 hours of volunteer service, representing nearly \$455,227 worth of contributed support and significantly strengthening its ability to serve students efficiently and responsibly.

Schedule I, Part I, Line 2 - Student LunchBox operates a coordinated campus distribution model based on the needs and capacity of each service location. SLB replenishes existing college food pantries and basic needs programs with recurring deliveries of food and essential goods. At campuses where additional access is needed, SLB also operates recurring farmers market-style mobile distributions that allow students to select items directly. SLB manages sourcing, warehousing, inventory preparation, transportation, delivery planning, and distribution standards, while designated campus teams coordinate local scheduling, student outreach, and access to the distribution site. Participant verification and intake procedures vary by distribution model. Some campus programs use current student identification as part of their check-in process, while TEFAP distributions follow applicable TEFAP eligibility and self-certification requirements. SLB maintains participation records across its distributions to document services provided and track program reach.
