Student LunchBox, Inc. (SLB) advanced its mission to promote academic success by delivering consistent access to nutritious food and other essential supplies for students facing economic hardship and other adversities. Through a three-tiered distribution model, SLB served 154,249 student participants, including 43,538 unique individuals, across 15 partner colleges. Weekly distributions included fresh produce, protein items, pantry staples, clothing, toiletries, hygiene products, and other necessities. These integrated services reduced financial strain, supported student well-being, and contributed to improved academic retention and success, effectively supporting sustainable practices while furthering the Organization's mission, goals and values.

Explanation

It is the organization's understanding that due to the wildfires that affected Los Angeles County in early 2025, and due to the burden on the communities affected, including a wide-range of neighborhoods bearing the additional stress caused by disruptions to businesses, its employees, usual flow of traffic, amongst other factors, that the deadline to present a regular tax filing on the Fifteenth Day of the Four Month for the year ended December 31, 2024 was duly extended for all filers registered in the Los Angeles County for a period of six additional months with a new deadline of October 15, 2025. As such, and in compliance of the published relief, the organization is submitting its tax filing within the extension timeline provided and prior to that date when the adjusted deadline comes due.
